## Boca Raton Ordinance 5356

### 1. What is Ordinance 5356?

This is a proposed ordinance that preserves City-owned land along the Intracoastal Waterway (ICW) for recreation. <http://bocawatch.org/understanding-the-ordinance-to-save-boca-ratons-intracoastal-parks/>

### 2. Why is it needed?

It is required to ensure that the citizens' voice is heard regarding usage of City-owned ICW land. <http://bocawatch.org/is-our-city-council-listening-at-all/>

### 4. What have citizens done so far?

### 5. What is the relationship between the Ordinance and the Wildflower property?
